

#### Management Requirements of China Compulsory Certification Mark

According to the Regulations of the People's Republic of China on Certification and Accreditation, Regulations for China Compulsory Certification, and Management Measures on Certification Certificate and Mark, CNCA stipulates the following requirements for the format, category, printing and use of China Compulsory Certification mark (hereinafter referred to as the "CCC mark").

#### I. CCC Mark Format

The CCC mark pattern is oval in shape, as shown in the diagram below. Mark vectograph can be downloaded from the CCC column on CNCA's official website.

## II .CCC Mark Category

The CCC mark is divided into three categories: standard CCC mark, printed / molded CCC mark and electronic CCC mark.

1. The standard CCC mark is pasted in the designated area of the product, featuring a white background and a black pattern. The mark comes in five different sizes, as shown in the table below.

Note: A and B refer to the length of the long and short axes of the oval outline of the CCC mark, respectively, with units in mm.

2. The printed/molded CCC mark is directly applied to the designated area of the product by using techniques such as printing, molding, silkscreen, painting, etching, engraving, or branding. The choice of colors for the mark can be based on the overall design of the product or the nameplate, and the size can be proportionally scaled up or down as needed.

3. The electronic CCC mark is displayed electronically on the integrated screen of the product (the product cannot be used normally if the screen is disassembled). The choice of colors can be based on the design of the product or the screen display, and the size can be proportionally adjusted.

## III.CCC Mark Printing and Labeling

The product included in the China Compulsory Certification Catalog can not be manufactured, sold, imported or used in any other commercial activities unless it

obtains the CCC certification (including self-declaration) and is labeled with the CCC mark. Certified organizations can choose the appropriate way to label the CCC mark from the following methods in consideration of the characteristics of the product. If the certification rules indicate the labeling of CCC mark otherwise, such rules shall prevail.

# 1. Standard CCC Mark Labeling Method

The standard CCC mark shall be printed by the designated certification body. The designated certification body shall ensure that the standard CCC mark's printing quality complies with laws, regulations and relevant national standards; it shall encompass identifiable anti-counterfeiting measures, have a clear, complete and wipe-resistant mark pattern, and be firmly pasted.

Manufacturers of certified products with a valid CCC certificate (or self-declaration) can purchase the standard CCC mark from the designated certification body. The purchased mark can be used for all certified products of the manufacturer.

The standard CCC mark shall be applied to the prominent place on the outer surface of the certified product. If the certification rules indicate the place of the CCC mark otherwise, such rules shall prevail.

# 2. Printed/molded CCC Mark Labeling Method

The printed/molded CCC mark shall be designed and made by the certified organization according to the product specifications. The mark shall be inseparable from the product or its nameplate, with a clear, complete, and distinct pattern. The printed/molded CCC mark shall be pasted to the prominent place on the outer

surface of the product or nameplate.

## 3. Electronic CCC Mark Labeling Method

The electronic CCC mark is only applicable to the products with integrated screens and electronic nameplates. The mark shall be designed and made by the certified organization in accordance with the product specifications, with a clear, complete, and distinct pattern.

The electronic CCC mark is displayed on the integrated screen in an electronic manner. Product manuals and other accompanying documents shall indicate the path for accessing the electronic CCC mark. Meanwhile, the smallest sales package shall include the standard CCC mark or printed/molded CCC mark.

## 4. Special Labeling Method

In principle, the CCC mark shall not be deformed in use. For special products that require the use of deformed CCC mark, corresponding provisions shall be specified in



the product's certification rules.

Products that can't use the above three labeling methods of CCC mark due restrictions in form, volume, etc., shall apply the standard CCC mark or printed/molded CCC mark to the smallest sales package or accompanying documents.

## IV.CCC Mark Management

Certified product manufacturers shall establish a CCC mark management system to truthfully record and archive the use of CCC mark. Certified organizations can apply the CCC mark to the product packaging, advertisements, and product introduction, but shall not use it to mislead and defraud consumers.

The designated certification body shall guide the certified organization in the correct use of the CCC mark and inspect the use of the CCC mark in the post-certification supervision.

The designated certification body shall truthfully record and archive the printing, and issuance of the standard CCC mark, ensuring traceability back to the manufacturers of the certified products.

Market regulation departments at all levels in conjunction with the supervision and inspection of CCC certification shall inspect the use of the Certificate within their jurisdiction. Any unlawful activity shall be investigated and dealt with in accordance with the laws.
